# Dublin Bay – Protecting the Bay for our Future

## Minister has power to stop Bay infill plans - Clontarf Public Meeting told

Clontarf residents were told that the Minister for the Environment, Heritage and Local Government, John Gormley has the power to halt plans by the Dublin Port Company to infill 52 acres in Dublin Bay.

The residents were attending a public meeting for a progress report on developments regarding Dublin Bay organised by independent councillor Bronwen Maher. The meeting heard reports from Cllr. Maher, Joe Nolan - Dublin Bay Watch, Joe McCabe - Clontarf Residents' Association, and Seán Dublin Bay Loftus.

Cllr. Maher, who is Chair of the Dublin Bay Task Force, said that "the Minister, as a member of Government, representing the State, which owns the Dublin Port Company, can request the Port Company to withdraw its planning application until the ongoing studies on the bay are completed".

"The Minister announced that he has put proper planning top of his agenda in the Department of the Environment. This is an excellent opportunity for him to halt the Dublin Port Company's plans and let the people of Clontarf know that he is putting his planning claim into practice."

## Stop the Bus Cuts!



In January Minister for Transport Noel Dempsey published a report he commissioned on Dublin Bus. He claimed Dublin Bus was inefficient, that there was a need to simplify routes and announced the dropping of various routes with the loss of 120 jobs.

**But wait. What does a simplified route system mean for Dublin's public transport commuters? It will mean elderly and disabled persons having to walk longer distances to a bus stop. It will mean taking two buses instead of one. Ultimately it will mean that those who rely most on public transport will suffer most. Yet at a time of increasing unemployment the need to use public transport will become even greater.**

The Minister says bus users deserve a better bus service. If that is the case, why is Government funding for Dublin Bus, at 29%, one of the lowest subventions for a public transport system in Europe? In Brussels it is 68%, in Amsterdam 62% and even in London, where the system is privatized, it is 38%.

Put simply, a well-serviced, efficient, clean and affordable public transport system should be a basic bedrock for any city, economy or democracy.

## Bronwen's Eco – Watch

### Allotments planned:

St. Annes Park Nursery, adjacent to the old green waste depot, is to be the location for a new pilot scheme to provide allotments for city dwellers. The walled garden area can provide up to 45 plots with lock-up stores, composting and a community garden area.

It is also envisaged that the allotments will also act as demonstration sites encouraging people to grow vegetable and fruit in their own back gardens.

### Wildlife Habitats – Biodiversity Plan :

Bull Island, St. Annes Park, hedgerows and back gardens are home to a wide variety of birds and wildlife - up to 30% of the city's habitat comes from private gardens. Dublin City's Biodiversity Plan identifies and maps important feeding and nesting sites which will now have to be considered alongside planning applications. The city council's Biodiversity Officer has just completed a Management Plan for Bull Island.
