

Even the rain, which fell steadily throughout the afternoon, failed to dampen the enthusiasm of the many thousands of Loyalist supporters who attended the massive rally in support of Segregation for Loyalist Prisoners, on Saturday 20 August. The parade which started off from the foot of Shankill Road. and made its way up Crumlin down Agnes Street and on to the Shankill, culminating in a rally at Woodvale Park, drew a larger crowd to the Shankill Road than was evident on Lisburn Road for the 12th demonstration. last month. From a given point facing Crumlin Road prison, it took the marchers over two hours to pass. Approximately 25,000 supporters lined the route, making the parade and rally a tremendous success. The marchers

themselves responded to the occasion admirably. There was no evidence of unruly behaviour and everyone enjoyed the day out. the 76 bands which accompanied the parade, added colour to a rainy with some very enjoyable music.

Up at Woodvale Park the speakers played their part by adding their voices to the clamour for Segregation. Surrounded by a sea of flags, banners and placards, each speaker outlined his own personal argument in support of this emotive issue. In each corner of the park, the vendors were kept busy serving up hamburgers and soft drinks, in what one described as a 'carnival' occasion. They were sold out in just over an hour. Outside, the road was a hive of activity, as shoppers ming-

led with the constant stream of marchers who were still making their way to the rallying point.

Because it was such a trouble-free day, the local press, including radio and television paid scant attention to the event, preferring more 'local' news items like the train crash in the Republic of Ireland, and the INLA'S latest death-threat. The absence of hijackings and bus-burning' ensured that little mention was made, which makes one tend to believe that the media actively violence on Ulster encourages streets.

It certainly isn't oul' Oireland no matter what he says because after poring over hefty volumes I failed to trace the lineage of the Adams family in any Irish context. In fact, the only Adams family he reminded me of was the one that appeared weekly on our television sets in the guise of comedy. I was prompted into this research by a letter from a Larne reader to the Belfast Telegraph, in which the writer asks 'Which country spawned Gerry?' THE FACT-FINDERS
Two recent visits by American, IRA sympathisers deserve a mention in these columns. NORAID and the Irish National Caucus arrived and departed in a wave of publicity. I was rather worried about Martin Galvin, Noraid's leader. Worried because he gave everyone the impression that he had recently escaped from a mental hospital. Father McManus (now there's a good Catholic name!) was a different kettle of fish, although he too has a lot of Protestant blood on his hands. ## THE DISCRIMINATED MAJORITY

Jim Watson, who has been campaigning for years in Ulster for the underprivileged has issued a challenge to Ulster's MEP's and the Ministry of Defence. He wants them to explain why he had to personally 'work his ass off' in order to secure an award of £1,600 for South Belfast widow, Mrs Doherty, who lost her husband in a murder attack by the IRA in the Stag Inn. Jim had this to say in an interview with this paper:—

"I want these people to tell me why Mrs . . . . whose husband and young daughter were blown to pieces in front of her eyes, and whose young son was badly injured in the same explosion, only received a paltry £6,000. Why little Tracy Munn's mother, whose little girl was blown to pieces on the Shankill Road, was offered the measly sum of £40. (Which she refused). These things have been bothering me lately, especially when one reads in the Republican press of the callous treatment by the DHSS of Bernadette and Archie Livingstone, who received £18,500 for the death of their daughter Julie. I know that no sum of money can ever replace the life of a loved-one, but if Gerry Adams (whose associates were responsible for the atrocities) can call this Livingstone case - 'callous treatment', I want an explanation for the treatment of Loyalist victims. If nobody is prepared to give me an

explanation, then I am intending to publish a list of all the compensation cases which I personally have knowledge."

With regard to the plight of prisoners I must advise all Loyalist paramilitaries to watch out for those politicians who would try and advance their own political careers on the prisoners 'Bandwagon'. Progressive thinking has not exactly been the hallmark of some of our councillors and M.P's. We have only to cast our minds back to June 1974, after the heady victory of the Ulster Workers Strike. I well remember those politicians who did not have the courage of their convictions until well into the second week, when victory was assured. There are those in present day Ulster politics who are only paying lip -service' to your fight for separation for our prisoners. 



# Ulster Defence Association Warns Young Thugs

The South-East Antrim Brigade of the Ulster Defence Association is seriously concerned at the spiralling crime-rate in the Newtownabbey area. In a report to the Newtownabbey Times on August 10th, a spokesman for the UDA outlined to the press, the ever-increasing crime-rate which has been plagueing the area for some time. In most cases the victims were senior citizens, and thousands of pounds worth of household goods were being stolen in what the UDA described as 'organised' crime. Last week I contacted a senior Officer in the organisation in Monkstown, who had this to say:—

A drastic situation must be met with drastic measures, and I am warning the 'Fagin'-types in the area to desist from this anti-social activity, or face the consequences. We have been innundated with cries of help from local people—many of whom are complaining about lack of police protection in the borough of Newtownabbey, generally. There is no intention on our part to 'upstage' the local RUC, but to be perfectly honest, we feel that a lot more could be done to counteract crime.

The lowest type of theft in the area apppears to be house-breaking, during which the gas or electricity meter is broken open and the contents removed. Many of the victims are already on the 'breadline' due to the recession and the inherent unemployment situation, which has left one-in-four people jobless. The vast majority of victims cannot afford house insurance. Once their property is stolen or damaged, they have no recourse to compensation. There are recorded cases of young children aged between 10 - 12 stealing from meter-boxes in order to buy glue. Regardless of opinion- of polls, 'glue-sniffing' is on the increase in the Newtownabbey area, and

this craze can be definitely connected to the crime-wave. Thefts from cars, clothes-lines and private garages are also of growing concern.

We have decided to step-up surveillance on certain gangs of youths in the Monkstown and Rathcoole areas, who are simply terrorising the community. We are taking drastic measures against known thieves who are operating schools for crime in a highly-lucrative spree of shopburgling, house-breaking and car-stealing. Unlike Catholic West Belfast, the Newtownabbey area does not have 'summer schools of terror' where young children are taught how to make petrol-bombs. There is no manipulation of young people by the paramilitaries as is the case in an area such as Andersonstown. There is little evidence of sectarianism despite the fact that Rathcoole estate houses many Catholic families, who moved away from troubled areas. Newtownabbey is certainly not a 'No-go' area as far as the law is concerned, but is the UDA determined to make it a 'No-go' area for thieves and miscreants?

#### IRELAND'S MOST WANTED PUBLIC ENEMY NO. 1



29 year-old Dominic McGlinchey is being described by Ulster police chiefs as 'the most wanted man in Ireland'. Nobody would quarrel with that title when one considers that McGlinchey is wanted for questioning about 20 murders and a host of other serious crimes in Northern Ireland. According to a police spokesman - 'he is wanted urgently and is considered dangerous. He may be armed and should not be approached by a member of the public. It is in the community's interest that he should be arrested as soon as possible'.

#### I.N.L.A's TOP 'HIT MAN'

Despite the facts pertaining to Mc-Glinchey, and allowing that he is the Irish National Liberation top gunman, it is all the more remarkable that the security-forces with their superior intelligence, can not produce a solitary photograph of this Republican killer. This would lead one to suspect that he has never graced the inside of places such as Gough Barracks or Castlereagh. And if not — why not?

It would appear that the only real clue to McGlinchey's identity is an 'identi-kit' picture issued to the local press on Saturday 13th August, 1983. McGlinchey was once regarded as a top IRA man who changed sides to the more militant INLA during the republican strike two years ago. He is regarded as being the 'master-mind' behind the brutal murder of Conservative politician, Airey Neave, the 'Droppin' Well pub bombing, in which 17 people died, and a host of other equally-serious crimes.

He is a Londonderry man, wanted on both sides of the border for possession of weapons.

Perhaps the RUC are depending upon yet another 'Supergrass' to tell them his whereabouts.

### 'RENT-A-CROWD' ROSE

Anyone sitting in the courthouse at Crumlin Road recently would have been forgiven for thinking that Ma Parker and the James Boys had clawed their way into the 20th Century. In the dock, during the Christopher Black Informer Trial, stood a frail old woman from Brompton Park, Ardoyne, who was charged with permitting her home to be used as a meeting place for IRA murderers. In the middle of answering questions directed at her by prosecuting counsel, Rose broke down and cried. To any Mick or Pat this was a heart-rending spectacle, but for others it was the first sign of remorse shown by the 'Grandmother of Terror' since the marathon trial had began.

There were many present who realised that Rose Harvey's tears were for herself and certainly not for the countless murdered victims whom she had helped to murder, by virtue of the fact that her house held many secrets, which will probably go to the grave with her. Rose Harvey's name will go down in Ulsters' colourful history and she will always be remembered as 'The one that got away'. Her age saved her wrinkled skin, but the ages of the victims did not save them.

With a roar of applause in her ears, the ageing harridan walked out of court accompanied by an entourage of IRA sympathisers, and held a hurried press conference underneath the scales of justice. There were no tears in her eyes then only defiance. Defiance of the law which foolishly let her off the hook. Her acquittal left a bad taste in the mouths of families of the dead victims. They must have stared at their television screens in disbelief, at the sight of this murdering conspirator giving the 'V' sign to the worlds' press.



JUBILATION:

In Brompton Park, and later in the Shamrock Club, Flax Street, the IRA's jubilation at her release was tempered with the realisation that a complete murder-squad of theirs was behind bars for a total of 4,000 years - courtesy of Chris Black. As the alcoholic fog descended, however, the strains of 'A Nation once again' and 'Kevin Barry' were heard drifting down Flax Street. It is doubtful if the newly-acquired prisoners from the same area heard the singing. They were too busy cursing themselves for trusting Black.

Dear Editor,

Since not being able to attend the Rally for Separation for Loyalist Prisoners on Saturday 20th Aug; I would like to make a few remarks on the welfare of prisoners, and also on your article Supergrass Syndrome (July issue). I believe that the welfare of all Loyalist prisoners will only be taken care of when an independent body, interested in prison reform, is given the authority to speak on behalf of these men. (I state 'Loyalist' prisoners, not on sectarian grounds but because the extreme Republican groups USE their prisoners, and there is no way I can see Morrison and Adams relinquish the power that they wield over the men behind the wire. If by some miracle they did, then I am sure that the same independent body would look into any Republican prisoners' grievance). The 'Supergrass' is something else. I believe that you, along with Republican groups have not studied in depth at what is known as the Supergrass Syndrome. You would imagine that Quigley, Kirkpatrick and Bennett were the first three Supergrasses in history, yet the fact remains that informers have been used throughout history. Most informers lack character. Bennett and Kirkpatrick had both been

guilty of abominable crimes, yet were acceptable by the security forces as good witnesses. Bennett did not even give a damn for his own family, and in saying that, I would plead with the Loyalist paramilitaries not to stoop to violence against the families of the Supergrasses. In Christopher Black case the judge referred to the girl who 'fingered' her Protestant workmate, by calling it 'The lowest type of informing? If, in the present state of our country, I was ever 'set-up 'by a lie from a paid informer, I would much rather represent myself in court, and depend upon both my ability and the Judge's wisdom.
