

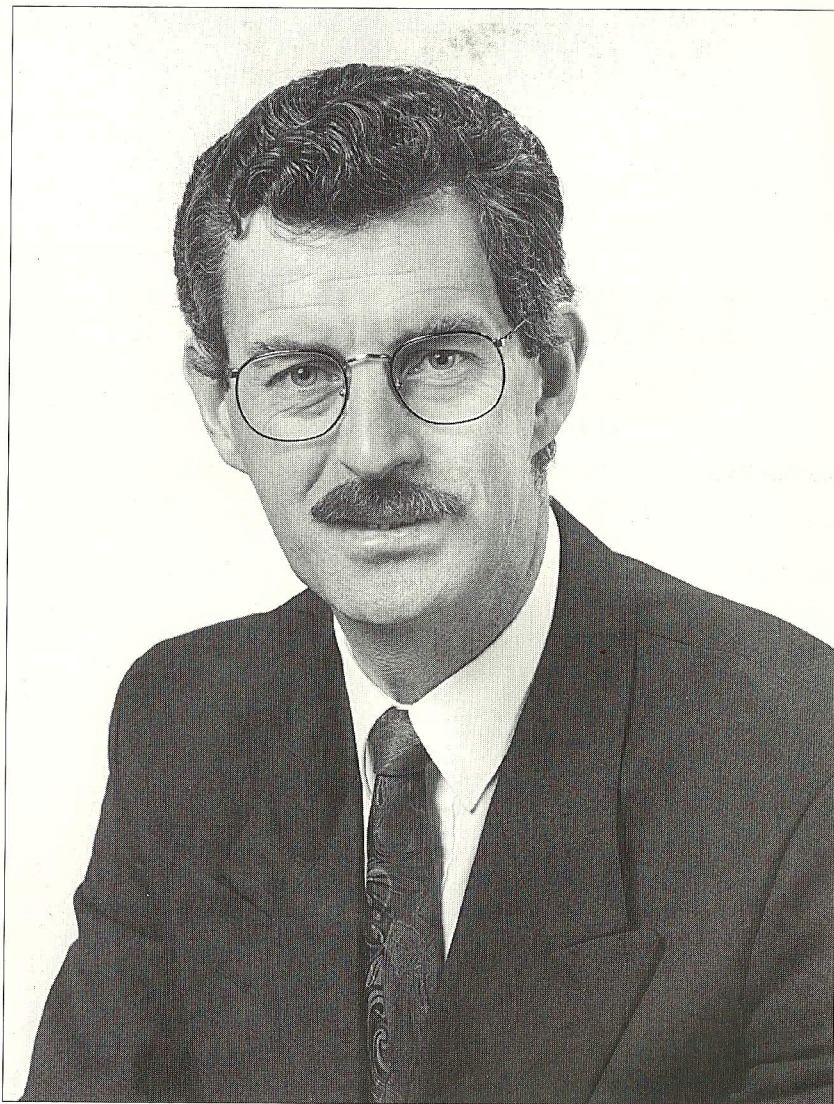

SECTION ONE (a)

The Administrative Council

Membership

The members of the Administrative Council (AC) elected by the 1991 National Conference held in Killarney, Co. Kerry, were:

Dick Spring TD, Party Leader, and Ruairi Quinn TD, Deputy Leader, are both ex-officio members of the AC.

Following the Party Conference the Parliamentary Party elected Michael Ferris TD, Brendan Howlin TD, Liam Kavanagh TD, Seamus Pattison TD, Brian O'Shea TD, Toddy O'Sullivan TD, as their six representatives on the AC.

Co-options

Under the Party Constitution, the AC has the power to co-opt two members from constituencies in the West of Ireland. At its meeting in February 1992 the AC co-opted Mary Kelly (Limerick West) and following the merger of the Independent Socialist Party (Sligo/Leitrim) with the Labour Party on 1st May 1992, the AC, at its meeting in May 1992 co-opted Declan Bree (Sligo/Leitrim).

Under the Party Constitution, the AC has the power to co-opt persons with special qualifications and at the May 1991 meeting, the AC co-opted Pat

Magner (Cork North Central) and at the March 1992 meeting, the AC co-opted Yvonne Fitzsimons (Dublin South East).

At its meeting in May 1991 the AC elected Alice Somers, Dan Browne and Emmet Stagg as the Party Trustees with the right to attend and speak at AC Meetings. It was also agreed that they be the Trustees of Labour Youth.

The Labour Women's National Council (LWNC), in accordance with the Party Constitution, appoints two representatives to the AC. Alice Somers (Dublin Central) and Yvonne Fitzsimons (Dublin South East) remained on the AC until October 1991. Following the AGM of the LWNC, the AC, at its meeting in November 1991, co-opted Emer Malone (Dublin Central) and Breeda Moynihan-Cronin (Kerry South).

The group of affiliated trade unions, in accordance with the Party Constitution appoints two representatives to the AC. Michael O'Reilly (ATGWU) and Eamon Devoy (AEU) were appointed in May 1991.

Labour Youth, in accordance with the Party constitution, appoints two representatives to the AC. In the period May 1991 to October 1991 these were Gerry Curran (Dublin North East) and Philip Long (Cork North Central). Following the Labour Youth National Conference in November 1991, the representatives were Gerry Curran (Dublin North East) and Michael McLoughlin (Dun Laoghaire).

At its meeting in January 1992, the AC appointed Des Cullen (Cavan/Monaghan), Kieran Hoare (Cork North Central) and Colette Costello (Laois/Offaly) as the AC representatives on the National Youth Committee.

In accordance with custom and practice, the Chairperson of the LWNC and the Youth Education Officer (YEO) have the right to attend and speak at AC Meetings. During the period covered by this report these were Dermot Lacey (YEO), Paula Desmond (LWNC) from May to October 1991 and Mairead Hayes (LWNC) from November 1991.

Following the resignation from the Party of Peter Connell in March 1992, the AC co-opted John McGinley at its meeting in May 1992.

Following the resignation of Niamh Bhreathnach as Party Chairperson on her appointment as Minister for Education in January 1993, Jim Kemmy TD became Chairperson, and at its meeting in February 1993 the AC elected Roisin Shortall TD as Vice-Chairperson.

International Secretary

The AC at its meeting in May 1991 re-appointed Tony Brown as the Party's International Secretary in an honorary capacity.

National Organiser

The AC at its meeting in May 1991 re-appointed Pat Magner as the Party's National Organiser in an honorary capacity.

National Conference

The 1991 National Conference was held in the Great Southern Hotel, Killarney, Co. Kerry, on 5th/6th/7th April 1991 with 1,262 registered delegates. There were 125 motions and 3 emergency motions tabled. Conference adopted one policy document - "Labour's Environment Policy - All Things are Connected", and one policy discussion document - "Social Welfare - Beyond the Welfare State".

Special Delegate Conference

In line with an Administrative Council decision of 7th January, 1993 a Special Delegate Conference was summoned for 10th January and met in the National Concert Hall in Dublin. The Conference considered a document presented by our negotiators with the Fianna Fail Party entitled "Fianna Fail and Labour Programme for a Partnership Government 1993-1997". The document was overwhelmingly endorsed as a consequence of which the Party joined with Fianna Fail in a Partnership Government on 12th January, 1993.

SECTION ONE (b)

Labour Women's National Council Report

1. **Annual General Meeting:**

The Annual General meeting took place at the ATGWU Hall, Dublin on the 2nd November, 1991. The following were elected to the Council:

2. **Council Meetings:**

Each constituency is entitled to send 5 delegates to Council meetings. Five Council meetings were held since the AGM.

Apart from Council and Executive meetings held during the year the LWNC was involved in the following activities.

3. **Workshops:**

The LWNC organised a workshop for Constituency Women's Officers in March 1992 to look at the role of Women's Officers.

Fifteen women including, some women candidates participated in a media techniques workshop facilitated by Fergus Finlay in May 1992. This included work on a closed circuit television. All who participated felt it was of great benefit and worth repeating. Our thanks to Fergus Finlay and all who participated.

4. **Seminar:**

A Seminar was held on Saturday 17th October, 1992. The subject was "Women in the 1990's en route to equality".

Participation in this seminar was sought from Women's groups, Trade Unions and other interest groups. There were working groups on Women and Development, Women and Health/Social Welfare, Women and the Labour Market, Women and the Law and Women and Decision Making.

The reports from this seminar will form the basis for a review of Labour Party policy on Equality. Our thanks to Barry Desmond, M.E.P. and the Socialist Group, European Parliament for their support.

5. **Questionnaire:**

The Council at its first meeting set itself the task of getting the views of its members through a questionnaire. It was circulated through the Women's Officers, and Council and Executive members. It was a worthwhile exercise and the Council would like to have the resources to do a further survey.

The questionnaire concentrated on six main areas

1. Profile of Women members.
2. Motivation and involvement of women.
3. Nature of involvement - positions held within the party.
4. Women's perspectives on the party, ie. what areas the party should develop in terms of policy and its public profile. (30% of the respondents chose Economic issues and 30% chose womens issues as priority areas).
5. Women's needs within the party and the role of the LWNC.

6. **Maastricht Treaty, X Case, Maastricht Protocol and Right to Life Referendum:**

A lot of the Council's time and effort has been devoted to the issues raised by the X case in February 1992 and the Maastricht Protocol and its effect on women's rights. The LWNC supported the Labour Party's "Eleventh Amendment to the Constitution Bill" introduced to resolve the

issues. The council's position (adopted at its council meeting on the 19th September 1992) was conveyed to Dick Spring, Party Leader at a meeting in October 1992. The LWNC were unhappy with the amendment wording in the Right to Life Referendum and were happy with its rejection and look forward to legislation to deal with the issue. The Council wish to thank Party Leader, Chair and Brendan Howlin for their tremendous work on this subject.

7. **International Contacts:**

The LWNC were represented by Mairead Hayes, Chair and Marion Boushell, Deputy General Secretary, at the Socialist International's commemoration of its first Women's Conference in Stuttgart in September 1992. Mairead Hayes also attended the European Parliament Socialist Group's Women's Working Group in Strasbourg in February, 1993.

8. **General Election:**

The LWNC's efforts to raise the profile of women in the party were given a boost in the 1992 General Election when 5 Labour women candidates were elected to the Dail and 3 to the Senate. Three were appointed to Ministerial Rank. Niamh Breathnach and Eithne Fitzgerald are both former Chairs of the LWNC. Joan Burton is a former LWNC delegate to the A.C. and Breeda Moynihan-Cronin is currently on the A.C. from the L.W.N.C. We wrote to 150 womens organisations highlighting our women candidates for the election and made a total donation of £400 to their campaigns.

Finally, the LWNC wishes to thank the members who attended and supported it throughout the year. A special word of thanks to all Head Office staff for their work and to the many other persons who lent support.

Labour Youth Report to National Conference 1993

Conference 1991:

Labour Youth's 1991 Conference was held from the 22nd to the 24th of November in Liberty Hall, Dublin.

Eighty two delegates attended from twenty two youth sections and trade unions. They were Dublin NC, NE, NW, S, C, SE, SW, DL, TCD and UCD, Cork SC, NC and UCC, Kerry South, Athy, Celbridge, Clane and New Ross.

The Conference was opened by Cllr. Sean Kenny, then Lord Mayor of Dublin. The Conference was also addressed by Ald. Ruairi Quinn TD and Ray Kavanagh, General Secretary of the Labour Party, who was the keynote speaker. Cllr. Mary Freehill, Tom Garry, General Secretary of SIPTU, Ray Kavanagh and Mairead Hayes, Chairperson of the LWNC took part in the Questions and Answers session on the Sunday morning.

The 1991 Conference marked a departure for Labour Youth in that for the first time we moved away from the plenary format and began to use workshops as a means of achieving a greater consensus and a broader range of options from within the Organisation. This was a success and was continued at the 1993 Conference.

The National Youth Committee:

The NYC met in January, February, March, April May, June, September, October and November 1992, January and February 1993, a total of 11 times.

At the first meeting of the NYC, Audrey Keenaghan was appointed Women's Officer and Mick McLoughlin was appointed to take care of Press duties. Paddy Glackin was appointed Honorary International Secretary.

Campaigns

It was agreed at the 1991 Conference that Labour Youth would conduct campaigns on the issues of unemployment, housing and abortion information.

Unemployment Campaign

This campaign was launched on the 30th March 1992 at a press conference in Dublin. Ruairi Quinn and Eithne Fitzgerald both contributed to the launch.

A document was published entitled "Exploding the Myth," the document was well received from outside and within the Party.

The central theme of the campaign "Exploding the Myth" was to heighten people's awareness of the problem, to put forward ideas towards a solution and above all, to illustrate to people that unemployment can be beaten.

The campaign had moderate success in having unemployment discussed and motions passed in several local authorities. Through work done in communities and colleges the unemployment problem was highlighted by Labour Youth.

Maastricht Campaign:

Due to a wide divergence of opinion within the Organisation, there was no concerted Labour Youth campaign on this issue. We did, however, call for a "Yes" vote with reservations. We issued a statement in conjunction with the youth sections of other Political Parties.

General Election:

Events overtook us on the "Right to information" issue and Labour Youth participated actively in the overall Labour Party General election campaign.

While Labour Youth shared the joy in the Party at the election of 33 Dail Deputies and 6 Senators, there was particular satisfaction at the election of former NYC member Pat Gallagher to the Dail and current Labour Youth member Ann Gallagher to Seanad Eireann.

The National Chairperson, Edward Dawson spoke in favour of the Labour Party participating in the partnership Government at the Special Conference in January.

International:

One of the great successes of the past eighteen months for Labour Youth was in the international arena. Audrey Keenaghan and Aimee Tallon represented Labour Youth at a seminar on Women and Health in Strasbourg in February.

Paddy Glackin, Labour Youth's Honorary International Secretary is currently a member of the control bureau of the International Union of Socialist Youth. Paddy has done a terrific job in Europe and has played a vital role in developing the high standing which Labour Youth enjoys in Europe at the moment.

Aidan Culhane represented Labour Youth at a series of events during the campaign for the Maastricht treaty as a guest of the Parti Socialiste.

The past year also saw the inception of two new international socialist youth organisations - the European Community Organisation of Socialist Youth (ECOSY) and European Socialist Youth (E.S.Y.) comprising I.U.S.Y. members in all European countries. Labour Youth is a founding member of both organisations. The document which we submitted to the ECOSY

constituent congress, on the subject of Unemployment and Social Policy was by and large adopted.

Due to a generous grant from the Swedish Social Democrats, Labour Youth hosted a conference in Dublin on the topic "Towards a Common Peace Policy" in January 1993. This marked a major departure for Labour Youth in that it is the first time we attempted such a project.

Another first for Labour Youth was the hosting of a visit from Die Falken, a German socialist youth group. The visit lasted over two weeks. Forty five Germans came and stayed at the campsite in Larch Hill.

The visit was partially funded by the Youth Exchange Bureau. Labour Youth has applied for funding for a return trip to Germany later this year. Initial contact with Die Falken would suggest that the trip would take place in August to Berlin and Kassel.

Summerfest:

1992 saw the return of Summerfest. It was held in mid-June in the adventure centre in Carlingford. About fifty five people participated over the weekend which was a success.

Discussions were held on Christianity and Socialism with Niamh Bhreathnach, Chairperson of the Labour Party and the parish priest of Carlingford. The meeting on economics was addressed by Brendan O'Rourke of The Institute of Education and Tony Moriarty of MSF.

A delegation from the SDLP spent the weekend in Carlingford and an interesting discussion took place on the subject of Northern Ireland which was also attended by Gavin Adams of the Ulster Young Unionist Council.

Colm O'Briain, former director of the Arts Council and theatre and television director gave a talk on the Arts and Socialism. The fact that the festival took place is a positive development and with a little effort we can expect a bigger and better event this year.

REVUE:

Revue has been the title of the Labour Youth journal for some years. It has never really taken off and this year saw an attempt to produce a regular magazine/newsletter.

REVUE appeared three times between December 1992 and December 1993.

The third edition which appeared in September was very kindly sponsored by MSF.

NYCI:

This year saw Labour Youth continuing its involvement in the National Youth Council of Ireland.

Congratulations are due to Dermot Lacey NYDO who was elected vice-president of the organisation at a by-election and subsequently at NYCI assembly. The significance of this is that it is the first time a representative from a political party has been elected to such a position in the NYCI. Tony Grace, vice chair of Labour Youth was appointed to the Youth Work Services Standing Conference.

NYCI Assembly was held in Limerick from the 20th - 22nd of November. Two delegates were elected to go to the Assembly. Dermot Lacey attended as vice-president on behalf of Labour Youth.

Aidan Culhane spoke at an unemployment forum organised by the NYCI in the Mansion House in April. This formed part of Labour Youth's unemployment campaign. Aidan also attended a question and answer session at the National Youth parliament in October.

Thanks:

Labour Youth wishes to place on record our appreciation to the P.L.P. and the A.C. for their assistance and to everyone in Head Office for their help and hard work over the last two years.

SECTION ONE (d)

Labour Lawyer's Group

Introduction

The Group's objectives are to provide advice to the Parliamentary Labour Party in relation to legal issues and to assist in the drafting of measures of law reform. Membership is open to any legally qualified Party member.

The A.G.M. of the Group took place on the 1st March, 1993. David Keane was elected Chairman, Grainne Malone, Secretary, Finbar O'Malley, Treasurer and Gerry Kelly P.R.O. During the year the Group continued to offer advice, when requested, to individual members of the Parliamentary Party and Local Representatives with respect to legal queries arising from their spokespersonships and from constituency work.

1. The General Election

Members of the Group were very active in campaigning on behalf of Party candidates in their own constituencies. Naturally, the General Election provided the focus of member's attention to the exclusion of Lawyer's Group activities over the Winter months.

2. The Document on the Rights of the Citizen

The Lawyer's Group was requested to prepare submissions on potential law reform for inclusion in a document on "The Rights of the Citizen" to be presented at a Special Conference of the Labour Party originally scheduled to take place in early May of last year. With great diligence on the part of several members, reports were produced on Landlord and Tenant Law, Family Law, Criminal Justice and the Scheme of Civil Legal Aid. It is heartening to see that so many of the Groups' proposals were ultimately reflected in the Programme for Partnership Government.

3. The Sub-Committee on the 8th Amendment To the Constitution.

This sub-committee, consisting of Diarmaid McGuinness B.L., Finbar O'Malley B.L. and Iseult O'Malley B.L. reported to the Group on a couple of occasions concerning Party Policy on the substantive issue and

on the rights to travel and information. In the aftermath of the X Case, the Party produced draft interim legislation which was voted down in the Dail. The 11th Amendment to the Constitution has necessitated fresh consideration of the relevant issues.

4. Other Activities

The Group considered a number of other topics in the course of its regular meetings during the year. Among the issues discussed were Reform of the Judiciary, a Penal Reform Bill implementing the proposals contained in the Whittaker Report and reform of the Law relating to Freedom of Information which was the subject of an address to the Group by Paul Callan S.C.

SECTION ONE (e)

Trade Union Group

The stated aims and objectives of the Trade Union Group are:

- [1] The affiliated trade unions recognise that many objectives of the trade union movement can only be achieved through political and legislative action and therefore are committed to increasing the strength and influence of the Labour Party at local and national level.
- [2] The Labour Party Trade Union Group shall strive to create conditions where contact between themselves and non-affiliated Unions may lead to a greater and fruitful involvement of more Unions in the life of the Party.

The Group which normally meets on a monthly basis, consists of the Group Officers and two (2) representatives from each Union affiliated to the Party.

Group Activities

In the period under review, the Trade Union Group played a very active role in political and related matters. The following can best summarise these activities:-

P.L.P.

A number of meetings took place between the Parliamentary Party and the Group to discuss items of mutual concern. For example, at a meeting on the 24th June, 1992 structures/procedures were agreed to promote more effective liaison between the P.L.P. and the Trade Union Group. Similarly a joint statement on the unemployment crisis was agreed following a meeting on the 28th October, 1992. In the coming weeks, the Trade Union Group will be examining its role in view of the Party's Partnership in Government.

May Day

With the agreement of the Party, the Trade Union Group has assumed responsibility for organising the Annual May Day Ceremony. In the period under review, two successful ceremonies have been held in the Labour History Society Building.

Political Seminar

The Group organised a seminar entitled "Trade Unions and Politics" on 13th May, 1992 in the Mansion House, Dublin. The seminar was opened by the Lord Mayor of Dublin Sean Kenny. It was addressed by the Party Leader, S.I.P.T.U. General Secretary Tom Garry and A.T.G.W.U. Secretary Charlie Douglas. It was chaired by the Mayor of Limerick Deputy Jim Kemmy

Labour Union Newsletter

The Group, as part of its development programme decided to publish a newsletter on a quarterly basis. The first edition was issued to coincide with the General Election campaign. Over eight thousand copies were distributed to union Officers/Officials, Local Representatives and shop stewards calling on trade unionists and their families to vote Labour.

2. At the Killarney Conference the Party Leader outlined his ambition that the Party would become the second largest in the state. Against this backdrop, the Parliamentary Party set itself the task of performing to a standard that would clearly indicate this in the Oireachtas, leading the opposition in a positive and coherent manner.

3. The Parliamentary Party played a key role in the Local Elections in 1991 and 17 of its members were returned. It wishes to congratulate the successful candidates and thank the Party Staff who assisted in this great victory.
4. The Beef Tribunal - the Party supported its establishment and the Party Leader Dick Spring T.D., and the General Secretary Ray Kavanagh have given evidence.
5. Privatisation - The Parliamentary Party fought vigorously against the privatisation of the Sugar Company and harried the Government in its successful attempt to sell off this taxpayer's asset.
6. Greencore and Telecom Controversies.
The Parliamentary Party was active in the Dail and Senate in bringing to the attention of the general public matters relating to these companies.
7. P.E.S.P.
The Parliamentary Party supported the Trade Union movement in voting for this programme in the Oireachtas.
8. The Treaty on European Union.
The Parliamentary Party considered at length the implications of this Treaty for Ireland. It wishes to thank the International Affairs Committee in particular for its invaluable advice on this complex subject. The Parliamentary Party supported the Referendum on this subject and the Party Leader joined with the Leaders of the other major political parties in calling for a "Yes" vote. This was accepted by the Electorate.
9. National Worksharing Scheme.
Ruairi Quinn T.D. (Deputy Leader) acting as Spokesperson for Finance and Economic Affairs published important proposals in this area in January 1992.
10. Emmet Stagg T.D. resigned the Whip of the Labour Parliamentary Party on 19th February, 1992 stating his reasons as being the behaviour of the Party in ignoring the Report of the Commission on Electoral Strategy's recommendation regarding Coalition. The Parliamentary Party categorically denied this charge. Deputy Stagg applied for re-admission at the meeting of 1st April, 1992 and he was accepted.
11. The Jobs Forum:-
The Parliamentary Labour Party took an active role in the Jobs Forum working constructively to contribute to a solution.

12. Jimmy Tully -
At its meeting on 20th May, 1992 the Parliamentary Party learned with shock of the death of its former Deputy Leader that morning. Warm tributes were paid to this outstanding Parliamentarian, Government Minister and Trade Unionist by all present. The meeting adjourned as a mark of respect.
13. At a Special Press Conference on 26th March, 1992 the Party Leader announced a number of major initiatives:
 - (a) An extensive re-assignment of the responsibilities of Parliamentary Party members and the appointment as Assistant Spokespersons of five councillors and our four senators:-

- (b) The establishment of the Tom Johnson Foundation which would be an independent research and policy development unit. Deputy Michael D. Higgins was announced as its first President.

14. The Equal Status Bill was the highlight of the Parliamentary Party's contribution to Private Members Motions. A major piece of legislation drafted with the assistance of the L.W.N.C. and the Labour Lawyers Group. It sought to outlaw all forms of discrimination on grounds of sex, marital or parental status, sexual orientation, religion, age, handicap, race, colour, nationality or national or ethnic origins, including membership of the travelling community. It was voted down by the Government parties.

15. **Sean McBride Peace Prize**

The Parliamentary Party extended its warmest congratulations to Deputy Michael D. Higgins on his receipt of the Sean McBride Peace Award. In a tribute the Party Leader said that this well deserved award was given for many years of solidarity with and work on behalf of the oppressed peoples of the third world.

16. **Michael Moynihan T.D.-** this outstanding member of the Parliamentary Party who had been a Dail candidate since 1954 announced his intention not to contest the 1992 General Election. His comrades in the Parliamentary Party expressed their thanks and admiration for Michael's long and loyal service to the Party as a T.D., Senator and Minister and the Party Leader made a presentation to him on behalf of its members. It was however the greatest tribute of all to

Michael that his South Kerry Constituents returned a Labour T.D. Breeda Moynihan - Cronin, on a substantially increased vote in the General Election.

17. **The November Referenda**

Parliamentary Party endorsed the Party position on the Referenda on the Right to Travel, The Right to Information and the so-called Right to Life. Having first sought to amend the third proposal in the Dail which was defeated by the Government, it went on to see the electorate accept its advice and defeat it at the Referenda which were held on the same day as the General Election, while accepting the Rights of Travel and Information.

18. **General Election 1992**

The Parliamentary Party enthusiastically contested this Campaign which was to be the Partys electoral highpoint in its 80 years of existence. The historic result which returned 33 T.D.s brought Labour into a Partnership Government with the Fianna Fail Party for the first time ever. This decision was reached at a Special Delegate Conference in the National Concert Hall on Sunday 10th January, 1993.

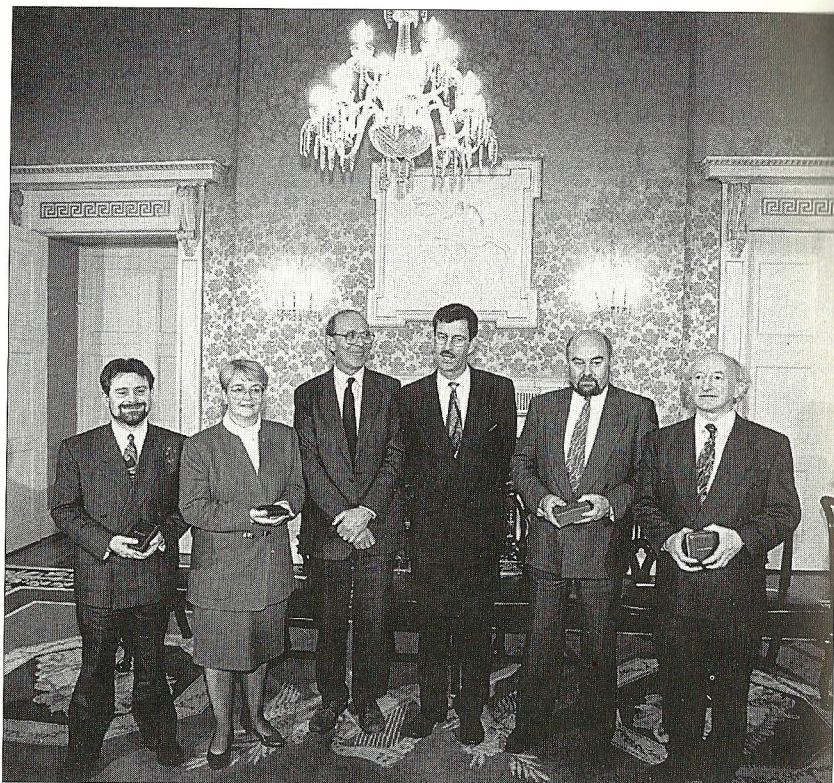

SECTION THREE

The Local Elections 1991

1. Elections to County Councils and County Borough Councils were held on 19th June, 1991. These elections had been deferred from the previous year and elections to UDC and Town Commissions were again postponed.
2. The Party was in a great state of readiness for these elections, many of the candidates having been selected up to a year beforehand and our National Conference in Killarney in April was used effectively to promote our aspiring candidates.
3. A local Government Election Committee was formed comprising of - Brendan Howlin T.D. (Chairperson), Ruairí Quinn T.D., Cllr. Eithne Fitzgerald, Seamus Pattison T.D., Michael Ferris T.D., Emmet Stagg T.D., Ray Kavanagh and James Wrynn. The Committee was assisted in its work by Denise Rogers, Sinead Bruton, Fergus Finlay, Mary Farrell and Ita McAuliffe.
4. 12,000 canvassing leaflets, 5,000 polling day leaflets, lapel badges, car stickers, issue posters in six themes, artwork for badges and leaflets, photographs of candidates, Party Leader posters and an Irish Language leaflet were all supplied free to each electoral area.
5. The Party contested in 134 of the 177 Electoral Areas (76%) and we fielded 201 candidates of whom 29 were women (14.4%).
6. The Campaign was characterised by high morale, Party unity, cooperation and cohesion. The Election Results showed an increase of 2.9% in the Party Vote - up to 10.63% and we won 32 extra seats - an increase of 55%.

SECTION FOUR

Merger of the Labour Party and the Independent Socialist Party (Sligo/Leitrim)

1. Negotiations between the Labour Party and the Independent Socialist Party (Sligo-Leitrim) were opened in December 1990 when the Party Leader Dick Spring T.D. and the General Secretary Ray Kavanagh attended a meeting with representatives of the Ard-Comhairle of the I.S.P. in Sligo.
2. Talks between the Parties continued through 1991 and in January 1992 a meeting in Sligo was attended by Ruairi Quinn T.D. Deputy Leader, Cllr. Joe Costello and General Secretary Ray Kavanagh on behalf of the Labour Party and Alderman Declan Bree, Pat Fallon, General Secretary I.S.P., Dr. Frank Dobbs and Dr. Margaret Connolly on behalf of the I.S.P. This meeting brought together the discussions of the previous year and draft merger proposals were agreed.
3. The Agreement was unanimously adopted by the Administrative Council and when put to the I.S.P. membership was overwhelmingly endorsed.
4. On May Day 1992 the agreement was formally signed at a Press Conference in Buswells Hotel, Dublin by Alderman Declan Bree and Pat Fallon on behalf of the I.S.P. and by the Party Officers of the Labour Party. This was the second anniversary of our merger with the Democratic Socialist Party.
5. In the General Election of November of that year Alderman Declan Bree was elected to Dail Eireann - our first T.D. in Sligo Leitrim since the foundation of the State. Party organisation in Sligo Leitrim now consists of six branches and we are represented on Sligo County Council and Sligo Corporation.

SECTION FIVE

Referenda

a) Referendum on the Treaty on European Union

1. The Treaty on European Union, commonly called The Treaty of Maastricht relating to European Political and Monetary Union was put to referendum on 18th June, 1992.
2. At its meeting on 27th May, 1992 the Administrative Council decided to support ratification of the Treaty on the basis of a recommendation presented to it by the International Affairs Committee. This decision was taken in spite of reservations on the Governments handling of the affair, including its failure to produce adequate information to the public on this very important matter and the infamous abortion protocol inserted by the previous Government.
3. The Party supplied leaflets, posters, briefing documents, car stickers and T-shirts to the Campaign.
4. Polling Day on the 18th June, 1992 resulted in the following:-
Turnout - 57%
For - 1,001,076 votes (69%)
Against - 448,655 votes (31%)

The Referendum had been carried in every constituency in the country.

b) Referendum on the Right to Life, Travel and Information

1. Arising mainly from a Supreme Court judgement on the so-called "X" Case allowing abortion in very limited cases the Government decided to propose a constitutional change restricting this further. It also included a right to travel and a right to information.
2. The Referenda were scheduled for the 3rd December, 1992 but due to

the collapse of the F.F./P.D. Coalition the date was brought forward to coincide with the General Election Poll on November 25th, 1992.

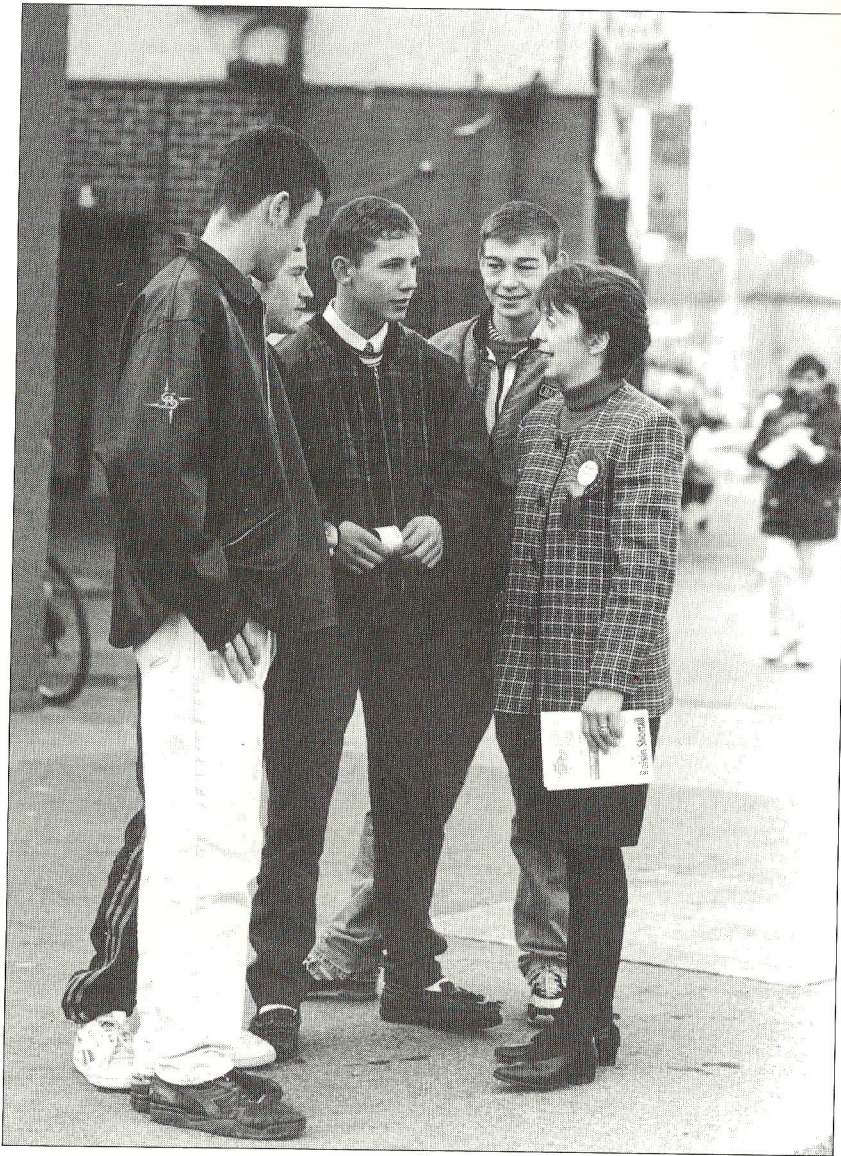
3. The Labour Party strongly opposed the Government proposal on the abortion issue and supported the right to travel and information. 100,000 leaflets were issued on the Referenda and distributed in conjunction with the General Election literature.
4. The results showed a massive rejection for the Abortion wording and support for the Rights of Travel and Information.

Dail and Senate General Elections 1992/93

a) THE GENERAL ELECTION 1992

1. The results of the Presidential Election in 1990 and the Local Elections in 1991 boosted party morale and together with Opinion Polls results over the period produced an atmosphere of optimism in the Party about significant Labour gains in the oncoming General Election.
2. In October 1991 the General Secretary produced a report on the Dail Constituencies outlining twelve target constituencies for Labour gains. On the merger with the Independent Socialist Party (Sligo-Leitrim) this became thirteen. All turned out to be Labour gains in the General Election with the extra four seats coming from Dublin South West (Eamonn Walsh), Dublin North East (Tommy Broughan), Cork East (John Mulvihill) and Clare (Dr. Moosajee Bhamjee) where the Party had magnificent victories.
3. During 1991 and 1992 the painstaking process of candidate selection was completed under the direction of the Organisation Committee. Candidate strategy proved particularly successful, so much so that it was attacked by the Taoiseach and taken up by the Media. In the event the Party with 19.3% of the votes gained 19.9% of the seats - an almost perfect ratio.
4. All through 1992 preparations for the Election continued, including a Media Relations Seminar, Photographic Sessions and in particular the decision to use the innovative black and white large-size election poster borrowed from Derek McDowell's successful local election campaign which dominated the Poster War nationally. Remaining candidates were selected, posters purchased, literature prepared and Directors of Election appointed.

5. When the Government collapsed on 5th November the Party was ready to campaign in a state of unity, high morale and preparation that had rarely been achieved in our history. A General Election Committee was established comprising of:-
Barry Desmond M.E.P. - Campaign Director of Election, Ray Kavanagh - Director of Organisation, Pat Magner - Leaders' Tour, Fergus Finlay, Sinead Bruton - Media/Information, James Wyrnn - Budget, Marion Boushell, Sally Clarke, Aidan McNamara, Dermot Lacey, Ita McAuliffe, Gregg Sparks and Marie McHale. The campaign slogan was "Lets make Ireland work".
6. From the very start the Party campaign met with a success that delighted and inspired our candidates and workers. The MRBI opinion poll in August gave us 12% this rose to 17% on 12th November and to 22% on 22nd. The IMS Poll showed us at 15% on 12th November and was 19% a week later while Lansdowne gave us 22% at the end of the campaign.
7. The Party Leaders Tour was a great success. Everywhere he was greeted with enthusiasm. Almost all constituencies in the country were covered in the tour and the reception given by members and electors alike was a prelude to the triumph of the Party in the election.
8. Polling Day was on Wednesday 25th November and by 11 p.m. the next day it was clear that the Party had won its greatest number of seats and its highest percentage since its foundation in 1912.

The Party fielded 42 candidates in 38 Constituencies. This included 8 women, 5 of whom were elected.

b) THE SENATE GENERAL ELECTION 1993

2. Absent from the list was veteran Labour Senator and constant poll topper Jack Harte whose retirement was accepted with regret by the

Administrative Council. Tributes were paid to his dedication and loyalty to the Party over many years both as Senator and National Organiser.

3. The Administrative Council also endorsed the candidacies of Mary Henry (Dublin University Constituency) and Anthony Clare (National University of Ireland Constituency)

5. The Party had 4 outgoing senators and gained one seat. (Mary Henry sits as an Independent Senator). Of our 5 elected senators 3 are women. The increase in our senate representation accords with the increase in our Senate vote from the Local Elections.

SECTION SEVEN

Finance and Accounts

Annual Accounts 1991, 1992

The Annual Accounts for 1991 and 1992 have been audited by the Party's Official Auditor and are printed as an integral part of this Report.

Accounts 1991

Income for 1991 amounted to £255,000. This was an increase of £40,000 on 1990 and was accounted for by an increase of £20,000 in the Party Leader's Allowance and £20,000 by the affiliation of S.I.P.T.U. who were not affiliated in 1990.

Local Elections represented a very substantial item of expenditure and the success of that year in the Local Elections is proof of money well spent. Of the figure of £104,000 just over £20,00 is represented by residual debts from the Presidential and Euro Elections.

Accounts 1992

This was a most successful year and the success of the Party was financially reflected in contributions to our Election Campaign. It can be seen that National Collection has fluctuated between 1991 and 1992 and this is largely due to late payments of 1991 National Collection in 1992.

Other Comments

It can be seen that at the end of 1992 our original £100,000 bank loan dating from the 1987 Election is now reduced to £13,000 and this will be cleared by June of 1993.

Outlook

The Party Leader's Allowance will be greatly reduced during 1993 because we are in Government, although this reduction will be partly offset by contributions of a greatly increased P.L.P. and by very substantial levies from Government Ministers.

In early 1993 income flows have been very good and the outcome at the end

of 1993 should leave the Party in a very solid position. In the coming period, if there is relative political stability, an opportunity is provided for the Party to address the major issue of its Head Office location.

Conclusion

May I take this opportunity of thanking every member, branch and constituency for their support and involvement in our financial activities over the last eight years.

International Affairs Committee

The Committee was re-appointed by the Administrative Council at its first meeting. The initial meeting was held on 23rd September 1991. Brendan Halligan was elected Chairman. The Committee met on eleven occasions.

Ita McAuliffe once again agreed to provide secretarial services in addition to her other duties and contributed substantially to the work of the Committee and of the International Secretary. The Committee has enjoyed the full support of Head Office Staff and of the Office of the Party Leader.

Policy Development

The Administrative Council, at its meeting on 29th May 1992, decided to publish two documents prepared by the International Affairs Committee as the Labour Party's contribution to the national debate on the Maastricht Treaty:

Conclusions, Summary and Analysis of the Treaty

Labour Party Statement: Security and Neutrality -
Principle in Foreign Policy

National Conference 1991

Conference adopted Resolutions on South Africa; Overseas Development Assistance; Socialist Group in the European Parliament; Baltic States; Eastern Europe; United Nations and the European Community.

Conference received Fraternal Delegates from PvdA (Netherlands); Labour Party (UK); SDLP; Socialist Group in the European Parliament; Confederation of Socialist Parties in the EC and Socialist International Women. The Embassies of Switzerland, Australia, India, Federal Republic of Germany, Turkey, People's Republic of China, France, Japan, USA, UK and USSR were represented.

Socialist International

The Party attempted to maintain close relations with the Socialist International despite the severe constraints imposed by financial resources. The International Secretary held a number of informal meetings with the General Secretary of the S.I., Luis Ayala.

The International Secretary represented the Party at the XIX Congress of the International in Berlin in September 1992 which was attended by representatives of as many as 150 parties and organisations from over 100 countries. Pierre Mauroy was elected as President in succession to Willy Brandt, whose message to delegates was received with great emotion. The Italian Party of the Democratic Left was accepted as a Full Member Party while Observer Party status was given, among others, to the Hungarian Socialist Party and the FSLN of Nicaragua - the Sandinistas.

The International Secretary attended a meeting of the Council of the SI in Berlin in September 1992.

The Labour Party was represented by Mairead Hayes and Marion Boushell at the Congress of Socialist International Women in Berlin, September 1992.

The International Secretary attended a meeting of the Council of the SI Middle East Committee in Strasbourg on 11th October 1991 at which representatives of Jordan, Syria and the PLO were present.

Death of Willie Brandt

Willy Brandt died on October 8th 1992. His death was mourned by the socialist movement worldwide, and by all committed to democracy, peace and justice. The Party Leader in a statement highlighted Willie Brandt's contribution to detente, disarmament and North/South relationships and his leadership of the SI over 16 years. The Labour Party was represented by the International Secretary at the State Funeral in the Berlin Reichstag on October 17th, 1992.

Confederation of Socialist Parties in the European Community

The Party continued to work closely with the parties of the Confederation in

the development of a socialist response to the rapid changes in European political circumstances and to the wide-ranging programme of the European Community. Guy Spitaels of the Party Socialiste Belge who had been elected President of the Confederation at the Berlin Congress in February 1990 resigned during 1992 on his election as President of the Wallonia Regional Executive. The Confederation Bureau meeting in Bordeaux on 10th July, 1992 elected Willy Claes, Foreign Minister of Belgium as President of the Confederation.

Party of European Socialists /PES

The parties of the Confederation, together with the Socialist Group in the European Parliament, decided to transform its organisation into a new structure, the Party of European Socialists with the goal of generating a fresh dynamism in policies and campaigning. The new Party will be in a position to benefit from the provisions of the Maastricht Treaty dealing with European Political Parties.

The founding Congress of the Party of European Socialists took place in Den Haag, Netherlands, on 9-10 November. The Labour Party was represented by the International Secretary and Barry Desmond MEP. The Congress adopted the Statutes of the Party. The Officers of the Party of European Socialists are:

The Labour Party has been fully represented on a number of Confederation/PES Working Groups during the past two years.

Socialist Group in the European Parliament

Full involvement in the Group, through the activity of Barry Desmond MEP who is Vice-President of the Group and Vice-Chairman of the influential Economic and Monetary Committee, has provided the Party with an increasing range of opportunities for policy discussion, education and exchange of experience.

Among the activities arising from the Party's involvement in the European Parliament may be listed: Seminar on Industrial Policy (M. Taylor TD); Conference on the Environment (B. Howlin TD); Conference on the Inter-Governmental Conferences (R. Quinn TD); Conference on Agriculture (S. Pattison TD); Seminar on Maastricht (R. Shortall TD, T. Broughan TD, D. McDowell TD).

Barry Desmond invited a series of groups of Party activists to Study Visits to Strasbourg and Brussels on 7-10 November, 1991.

Enda McKay, the Group Administrator dealing with the Regional Affairs Committee, has provided a most important link between the Group and the Party and has greatly assisted the work of the International Affairs Committee.

Friedrich Ebert Foundation / FES

An initial joint Seminar, on Neutrality and Security was held in Dublin on

24-25 May, 1991. The Seminar was attended by a number of Labour Party representatives and invited Irish experts together with politicians and academics from Germany, UK, Sweden, Finland, Cyprus, Switzerland, Austria and Hungary. An introductory paper was presented by Prof. Patrick Keating of TCD and a wide-ranging discussion took place.

A second joint Seminar on 'EMU after Maastricht' was held on 24-25 January, 1992 in the Mont Clare Hotel. Labour Party representatives were joined by Peter Schulze (FES); German MPs Norbert Wieczorek, Dietrich Sperling and Nils Diederich; Richard Coburn MP, British Labour Party; Prof. Dermot McAleese, Prof. David Coombes and Dr. Rory O'Donnell.

Brussels Support Group

The Brussels Support Group is being developed steadily and has the backing of a growing circle of Irish staff-members in the various Community Institutions. Arthur Kerrigan has been elected Chairman of the Group. Meetings have been addressed by the International Secretary, Brendan Halligan and Barry Desmond MEP.

Somalia

Michael D. Higgins T.D. visited Kenya and Somalia with a Trocaire delegation and his report graphically described the scale of the crisis stressing its political and humanitarian aspects. It was agreed that, in conjunction with other Parties in the EC and SI, all efforts should be made to bring about stronger United Nations resolutions and action. The Party Leader persuaded the Confederation Party Leaders to adopt a strong policy position on Somalia and argued for closer attention to the longterm issues, such as the implications of the arms sales policies of European states.

International Politics

The period under review saw many major and challenging developments in European and World politics, not least those connected with the ratification of the Maastricht Treaty. The Labour Party has attempted, within its financial and organisational limits, to play a constructive part in the worldwide socialist movement in facing up to this dramatic rate of change.

With the creation of the Party of European Socialists and with the expansion of its membership to include the Austrian, Swedish and Finnish parties the movement is now well placed to work internationally for the attainment of its declared goals of peace, development and human rights. The period ahead will see the enlargement of the Community and the commencement of very significant debates on issues such as security and defence in Europe.

As the Labour Party for the first time takes ministerial responsibility for Irish Foreign Policy, the Party itself will have to accord a higher priority and appropriate resources to this area of policy and activity. International politics provide the framework for all aspects of our national politics today and this fact will intensify in the years ahead - in the Single Market framework and beyond, and in a Europe which must develop a new and effective security and peace order. Labour's long-standing policy commitments and insights will provide a sound basis for Ireland's contribution to this historic process.

SECTION NINE

Obituaries

Paddy Bergin - Born in Carlow in 1913 he became a Sugar Cook in the Sugar Factory and from the beginning was involved in the Trade Union and Republican Movement. He was elected to Carlow UDC and County Council and unsuccessfully contested the General Election in 1948. He was full time Organiser for the Party 1951 - 1954 and was appointed to the Senate 1954 - 1957. Founding member of the Irish Labour History Society in 1973 and later its Honorary President. His warm personality, good humour and lifelong commitment to the Party made his death in April 1991 a great loss to us all.

Tom Byrne - a great loss to his Wicklow constituency following so closely on the death of his friend and colleague Frank Hynes. Tom was a member of the Labour Party for 56 years and was co-opted onto Wicklow UDC to replace the late Jim Everett in 1967 and re-elected on each subsequent occasion.

Jack Coughlan - A veteran of the War of Independence and a railway employee he founded the Tuam Branch of the Labour Party in 1922. He was elected onto the Board of Commissioners in 1934 and re-elected on each occasion until 1967 having twice been Chairman. He initiated a tenant purchase scheme in Tuam in the thirties which was the first in the country. He was responsible for the building of 400 houses in the town between 1934 and 1937.

Packie Gralton - He was a farmer on a smallholding in Drumsna, Co. Leitrim. He was of the tradition of rural radicalism in Ireland. He was President of the Independent Socialist Party (Sligo - Leitrim) until its merger with Labour on 1st May, 1992.

Frank Hynes - a longstanding and stalwart member of the Wicklow Labour Party. He was a County Councillor for 25 years where he represented Wicklow Electoral Area and was twice Chairman of the Eastern Health Board - a position he occupied at the time of his death in January 1993.

Paddy Murphy - a founder member of the Federation of Rural Workers and holder of all senior positions in that union. An executive member of the I.T.U.C. and later of the I.C.T.U. . A loyal Party activist who served as a councillor on Dublin County Council for 20 years. As Chairperson of its Housing Committee he presided over the biggest expansion of low cost housing in the history of the state. He was a man whose life and career embodied the link between the Party and the Trade Union Movement.

Cissie Roughan - a woman of immense courage and compassion in her private and public life. Her dedication to her family, her town of Kilrush and the Labour Party made her a symbol of all that is best in the Labour movement. The first woman Chair of Kilrush UDC of which she was completing her second term at the time of her death.

Jimmy Tully - organiser and General Secretary of the Federation of Rural Workers (1954 - 1973). T.D. for Meath 1954 - 1957 and 1961 - 1981. Deputy Leader of the Party from 1972 - 1977 and 1981 - 1982. He was Minister for Local Government 1973 - 1977 when he was responsible for the building of the remarkable number of over 100,000 local authority houses. He established An Bord Pleanála and was the first to propose Inner City Renewal in Dublin. In the 1981 - 1982 Government he was Minister for Defence. His immense contribution to the Party and the nation was reflected in the attendance at his funeral in Laytown on 29 May, 1992 when Party members from all over Ireland joined with his former constituents to bid him farewell.
