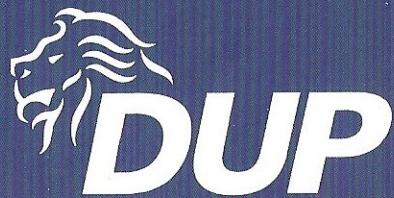

TO THE UNITED IRELAND PROCESS

IT'S RIGHT TO SAY "NO" WHEN THERE'S A BETTER WAY TO GO

NORTHERN IRELAND, LIKE ENGLAND, SCOTLAND AND WALES SHOULD HAVE:

1. **DEVOLVED POWERS** within the United Kingdom free from external influence.
2. **DEMOCRATIC** and accountable government with a Bill of Rights guaranteeing equality of rights, opportunity and individual esteem.
3. **POSITIVE** guarantees that the principles of democracy and the rule of law will apply to all.
4. **EXCLUSION** from government of parties fronting terrorism.
5. **ACCOUNTABLE** and democratic government at local level with an end to rule by unelected Quangos.
6. **MAXIMUM** use of existing channels of co-operation with the Republic to everyone's mutual benefit. An expensive layer of obstructive political bureaucracy is unnecessary.
7. **POSITIVE** commitment to cross-community recruitment to the Royal Ulster Constabulary, which should be free from political interference and undistorted by the threat of terrorist violence to any of its members.
8. **FREEDOM** from the barbaric brutality of paramilitaries for the communities which they seek to control by fear and intimidation.

REMEMBER - YOU'LL NEED ONE OF THESE TO VOTE

- both parts of a current NI driving licence, provisional licence or GB full driving licence
- a current passport
- a current benefit or pension book issued by the DHSS
- a medical card
- a current British seaman's card
- a card made of plastic issued by the DHSS or DSS with a name and national insurance number on it
- a marriage certificate in certain circumstances.

"The so-called Agreement is a devilishly devised transitional arrangement engineered to progressively convey Ulster, through all-Ireland functioning, into a united Ireland. Dear Friend and Voter

It was the Ulster Democratic Unionist Party which fought and obtained for you the right to have your say through a referendum on any deal made by the two Governments and the politicians. The Official Unionists actually opposed the right of the people to have such a referendum.

IT'S RIGHT TO SAY "NO" TO DUBLIN RULE



A VISION FOR UNITED UNIONISM

THE DUP IS WORKING ALONGSIDE FELLOW UNIONISTS TO SECURE ULSTER'S POSITION WITHIN THE UNITED KINGDOM. THE UNITED UNIONISTS ARE PLEDGED TO:

- reject the abandonment of the United Kingdom's sovereignty over Northern Ireland in exchange for an amendment of the Irish Constitution that renders Unionists a mere tradition in the Irish nation.
- refuse a Northern Ireland Assembly designed to feed power to All-Ireland institutions and to place in government over our people the delegates of terrorists who remain fully armed.
- recoil with moral contempt from an Agreement which releases back into our community those who have murdered and maimed the innocent, while the Royal Ulster Constabulary, who have protected the peaceful and the law-abiding, are to be demoralised and disarmed.
- repudiate all-Ireland bodies with executive powers and expanding authority designed to develop into a factually United Ireland.
- demand, as British citizens, equality of treatment, the protection of our lives, persons and property, and the return of a democratic and accountable government, free from the domination of violent political terrorism, and in which all citizens have

THE AGREEMENT WILL LEAD TO A UNITED IRELAND

IRA/SINN FEIN IN POWER

- IRA/Sinn Fein leaders are **guaranteed** places in the cabinet power-sharing government of Northern Ireland as Ministers with "full executive authority in the area of their responsibility." There is **no** requirement for the handing over of any IRA guns or explosives before Sinn Fein are admitted to the government of Ulster.

NATIONALISTS HANDED A VETO

- IRA/Sinn Fein and the SDLP are handed a veto on all key decisions within the proposed Assembly. No significant decision can be taken without the agreement of John Hume and Gerry Adams.

AN EMBRYONIC UNITED IRELAND GOVERNMENT

An all-Ireland Ministerial Council is created with the full Framework powers of consultation, harmonisation and executive decision-taking over a wide range of subjects. Unless this all-Ireland Council is up and running the proposed Assembly will be abolished. Unionists will always be in a minority within the all-Ireland body with no requirement for unanimity in decision taking. A Maryfield style secretariat is proposed to service the Council on an all-Ireland basis. Dublin's interference in Northern Ireland's affairs is intensified with the setting up of a series of all-Ireland, cross-border implementation bodies.

ULSTER'S CONSTITUTIONAL STATUS DESTROYED

The Government of Ireland Act which established the supreme authority of the United Kingdom Parliament over Northern Ireland is abolished immediately. In contrast the illegal claims in the Irish Republic's constitution are merely amended, but only in exchange for the setting up of "institutions with executive powers and functions" for the whole of Ireland. In any case the changes are conditional and provisional. This Agreement takes precedence over the Act of Union.

NO TERROR WEAPONS REQUIRED & PRISONERS GO FREE

There is no requirement for the handing over of any illegal terrorist weaponry. Mere aspirations pay lip service to the notion of decommissioning but, as during the Talks, there is no sanction imposed for a refusal to do so. The IRA have made it clear they will not decommission. All terrorist prisoners in Northern Ireland, including those convicted of murder and other terrible atrocities, are to be released within two years at the latest.

THE RUC TO BE DECIMATED

Under the terms of reference for the independent commission on policing, the RUC is headed for decimation and destruction. With its international input the Commission is required to bring in a report which will destroy the ethos, symbols and culture of the RUC. The Police Bill, which has just been passed at Westminster changes the name of the RUC to the 'Northern Ireland Police Service'.

YOUR SECURITY SLASHED

The Agreement provides for the removal of the Army, including the RIR, from its present role; the removal of all security installations; and the removal of the security forces' emergency powers to deal with terrorism. All this is to happen whilst the IRA remains intact, with all its top personnel released and all its stockpile of terrorist weaponry retained.

IT IS THIS AGREEMENT WITH ALL THE ARRANGEMENTS ESTABLISHED UNDER IT AND THIS AGREEMENT ALONE, WHICH WILL BE VOTED ON ON 22 MAY. NO OTHER CONDITIONS, WHETHER VERBAL OR WRITTEN GIVEN BY ANY OF THE PARTIES CAN OVERRIDE WHAT IS SET OUT IN THIS AGREEMENT.
