Constitution of Aontú Amendments

1. This Ard Fheis rejects the use of gender quotas by the party. Candidates, Ard Chomhairle members and Officers should be appointed based on merit. We are calling for an overhaul of the election process for Ard Comhairle and are calling for an end to the process of having separate election ballots for Males and Females.

2. That this Ard Fheis calls on all Aontú candidates to comport themselves respectfully in their public engagements and adhere to the guidance of the Aontú Ard Chomhairle in their public and political work. **Ard Chomhairle Aontú**

Education and the Irish Language

3. This Ard Fheis believes that the Water safety Ireland education programme should be made compulsory in primary schools.

4. This Ard Fheis calls on the government to monitor, record and publish monthly statistics detailing the number of young people emigrating and their professions, qualifications and occupations.

5. This Ard Fheis believes that early childhood services for 4, 5 and 6 year olds, like speech therapy, occupational therapy, mental health supports from the likes of CAMHS should be delivered through primary schools. The services should be brought to the children. The current method is not working and only generates reams of paperwork while failing to deliver the actual supports that children need.

- 6. This Ard Fheis calls on the government to require primary schools nationwide to facilitate the teaching of Ireland's national Anthem, Amhrán na bhfiann. Made compulsory from 3rd or 4th class.

In light of the recent delays in receiving state exam results, this Ard Fheis proposes that all newly qualified teachers should be contracted to assess state exams for at least three years during their teaching career. We also propose that all remuneration for all those assessing state exams should be tax free.

15. This Ard Fheis is opposed to developing the provision of *only* gender-neutral toilets and changing rooms in schools.

This Ard Fheis asserts the introduction of any SPHE or RSE curriculum into our schools should only occur following extensive consultation with parents and should be implemented in accordance with the wishes of the parents. That parents be given the right to scrutinise any books that schools have on site before these books become part of the curriculum.

That all Schools are facilitated to teach Relationships and Sexuality (RSE) fully in accordance with the ethos of that school. That all parents of school-going children are informed at least 48hrs in advance of any classes in which it is intended to show content not in line with the ethos of the school. That this Árd Fheis opposes Gender Ideology within the new SPHE or RSE programme and calls on the government to only teach SPHE on the basis of science and best medical evidence within the framework of the ethos of the school.

23. This Ard Fheis demands that every child of school age and deemed ready to attend school, should have a place in an educational setting which facilitates their needs, in agreement with parents and confirmed no later than 1st August.

- 34. That this Ard Fheis recognises with horror the collapse of elements of the Nursing Home sector and calls on the government to ensure proper funding and staffing for all.

49. This Ard Fheis calls on the HSE/ NHS to put in place Care Paths and Specialist Consultants for sufferers of severe M.E. (Myalgic Encephalomyelitis)

50. This Ard Fheis calls on the Minister for Health and his department to be more proactive in promoting good mental health among people of all ages and to fund and support the important research needed to explore the root causes of loneliness, self-harm and suicide.

51. This Ard Fheis calls for increased investment and recruitment into Acute Medical Services including births and paediatrics in Causeway Hospital.

52. This Ard Fheis calls on each council area to establish a mental health forum with a long term and annual plan, providing access to services in mental health and addiction following a transparent consultation completed in line with Equality and rural needs legislation.

The Economy and the Cost-of-Living Crisis

53. That this Ard Fheis calls on the government to prioritise the staffing of the health service, the education service and the Gardaí in this Budget. The necessary pay terms and conditions must be developed to ensure men and women will work in these sectors. That the government will put in place workforce planning to ensure that the necessary staff for these sectors and the construction come through the education system.

54. This Ard Fheis notes with alarm a recent opinion poll which found that 70% of those aged between 18 and 24 years intend to emigrate and calls on the government to conduct research among our emigrant population to determine what it would take for them to return to Ireland, and immediately tackle this problem.

55. That this Ard Fheis calls on the Government to institute a scheme to install free solar panels on occupied residential buildings, at the request of homeowners and subject to survey, and that any income earned by selling electricity supply to EirGrid through this scheme should be split equally between the Government and the homeowners.

This Ard Fheis calls on the Minister of the Environment to initiate a comprehensive review of Local Government funding with a focus on commercial rates for retail businesses in light of the shift away from bricks & mortar to online retail by consumers which necessitates reform so as traditional and online business are treated equitably.

57. That this Ard Fheis notes that Excise Duty makes up a large part of the price of petrol and diesel in Ireland. This Ard Fheis calls on the Government to halt its staged increase in Excise Duty on diesel and petrol on October 31, 2023 and reverse the increases already made on June 1, 2023 and September 1, 2023.

58. Ógra Aontú proposes for Aontú to take a stance regarding carbon tax and excise tax: We call on Aontú to formally campaign and support the reduction of carbon tax and excise tax on petrol and diesel to alleviate the cost of the living challenge and reduce the strain on costs for farmers, hauliers, small businesses, and drivers in Ireland.

59. Aontú calls for youth returning to Ireland after a long period to have full social welfare rights as if they never left, as that is the minimum a citizen deserves.

60. This Ard Fheis believes that the TV licence should be abolished and that the relevant criminal records of those who have been prosecuted in recent years for not having a TV licence, be cleared.

61. This Ard Fheis calls for the abolition of Uisce Éireann and for water responsibility to be returned to local councils.

62. This Ard Fheis notes that Ireland's Total Public Debt at the end of 2022 was €226 billion, one of the highest per capita debt burdens in the world. This Ard Fheis calls on the Government to ensure that in

its next Budget no deficit spending takes please nor any measures without quantifiable return are taken which will increase the Public Debt.

- 63. That this Ard Fheis supports the development of nuclear power in Ireland. A national plan should be formulated to begin the process of constructing nuclear reactors to meet Ireland's growing energy needs. **Plunkett Cumann,Belfast**
- 64. That this Ard Fheis calls for research to be carried out on the imposition of a windfall tax on bank profits, modelled on the Czech government's three-year 60% levy on bank profits exceeding 120% of the average made between 2018-21.

65. That this Ard Fheis believes that if a digital euro is created, it must have the same properties as cash and fully respect the privacy of its holder. EU citizens should further have the right to store their money digitally at the ECB without restriction, enabling citizens to make digital transactions without the necessity of relying on private for-profit banks and clearing houses as intermediaries.

66. That this Ard Fheis supports the development of Irish worker-owned co-operatives, along the model of the Mondragon Corporation in the Basque Country.

That this Ard Fheis proposes that Aontú take on a stance regarding the Universal Social Charge (USC): We call on Aontú to research the abolition of USC due to; record surpluses in the national budget and unfulfilled promises to the taxpayer in Ireland that are an act of grave breach of trust to the taxpayer entity. We seek to give a long-awaited break to workers by making work pay through the abolition of the USC.

68. Ógra Aontú proposes for the Aontú to take on a stance regarding minimum unit pricing and VAT on alcohol: We call on Aontú to formally campaign and support the abolition of minimum unit pricing and a VAT decrease on alcohol to 15% by which reducing the burden of cost to young professionals, publicans, students, and alcoholic-beverage enjoyers.

69. That this Ard Fheis calls on the Government to carry out an audit of all NGOs in receipt of state funding to ascertain the cost benefit to citizens of that funding. That the government ensure that only funds that have a real benefit to citizens are expended.

That this Ard Fheis calls on the Government to ensure that all Non-Government Organisations (NGO's), who receive State funding, provide access to their accounts to the Public Accounts Committee and other relevant Government Committees and that their disbursement of State funds be subject to public scrutiny. **Dublin Rathdown Cumann, Ógra**

- 70. That this Ard Fheis calls on the government to end toll charges on state owned motorways. **Ógra**
- 71. That this Ard Fheis calls for payments to the EU to be significantly decreased and seeks to actively promote Irish values: our own sovereignty, neutrality, etc. **Ógra**

72. That this Ard Fheis calls for the property tax to be abolished, and for bonds to issue to citizens to repeal and repay property tax to citizens without having a negative immediate impact on current cash flow and finances.

73. That this Ard Fheis calls for the government to cap childcare costs to support working families especially working mothers, so that going out to work isn't robbing them of precious time with their family yet proving to be of little financial benefit.

74. That this Ard Fheis calls on the government to allow taxpayers to use all of their spouses'/civil partners tax – free allowance if their spouse does not work or the remainder if their spouse/civil partner earns less than the threshold.

75. That this Ard Fheis acknowledges the growing trend of businesses only accepting card/contactless payments. That this Ard Fheis also acknowledges the risks posed to consumers by a cashless society in regard to privacy and security, including government and bank surveillance of transactions, data mining, fraud and political repression. That this Ard Fheis applauds the work carried out by Aontú in opposing moves to cashless by the NCT and the GAA.

This Ard Fheis proposes that all future services delivered by Government and Local Authorities should insist that, where payments are made by members of the public, a variety of payment methods should be offered including cash. That this Ard Fheis calls on Aontú to support legislation prohibiting businesses in the retail and hospitality sectors from refusing cash payment, with reasonable exception for goods/services that require collateral, such as rented products.

76. This Ard Fheis calls on the government, industry, local authorities and other relevant parties to prioritise, promote and provide more employment opportunities for persons with Autism and for others with physical and intellectual disabilities.

78. This Ard Fheis calls for a long-term funding commitment for community transport services from the Department for Infrastructure (Dfl). 79. This Ard Fheis calls on the Minister of the Environment to initiate a comprehensive review of Local Government funding with a focus on commercial rates for retail businesses in light of the shift away from bricks & mortar to online retail by consumers which necessitates reform so as traditional and online business are treated equitably.

80. This Ard Fheis calls on the Minister of Finance to give more supports to An Post and Credit Unions so that banking facilities are available in more localities creating some competition to the present duopoly. **Cathal Brugha Cumann**

81. That this Ard Fheis recognises the increasing crisis developing in Early Years Education and Childcare sector and fully supports the representative's groups in their strike against the Government's reduction in income supports to the smaller providers.

82. That this Ard Fheis demands that the Government take responsibility for the enforcement of regulation of the Construction Industry to include 'fit-for-purpose' certification for all building materials in order to establish confidence in the viability of current building materials, calls for end to the bureaucratic efforts by this Government to deny a Just Redress to the victims of homes and buildings constructed with unregulated deleterious materials. We call on this Government to negotiate, immediately, with banks and lending institutions, to put in place, zero interest loans for property owners involved in the demolition and reconstruction of buildings affected by deleterious materials.

83. This Ard Fheis calls upon the Government to immediately rescind and review the implementation of this discriminatory RZLT - Residential Zoned Land Tax, due to the punitive costs attached, in the midst of a cost-of-living crisis.

84. This Ard Fheis calls on the government to ratify the 'Optional Protocol' which accompanied the UN Convention on the Rights of Persons with Disabilities, which would allow people to make complaints to the UN Committee on the Rights of Persons with Disabilities against Ireland.

85. This Ard Fheis condemns the treatment of the Uyghur Muslim population in Xinjiang by the Chinese Communist Government.

86. This Ard Fheis calls on Dún Laoghaire Rathdown County Council to carry out an audit of all aspects of their Active Travel infrastructure to review accessibility and safety for those with disabilities, mobility and vision impairment.

87. This Ard Fheis calls on the government to increase their efforts to tackle persecution of Christians worldwide.

Corrib Cumann, Galway

88. This Ard Fheis endorses the 'Consistent Life Ethic' philosophy which opposes the intentional destruction of human life in all forms - abortion, the death penalty and euthanasia. That this Ard Fheis opposes the use of taxpayer money to fund abortions.

Ógra, Corrib Cumann, Galway

89. This Ard Fheis notes with concern the fact that Ireland was recently placed on an international watch list for our poor record on human trafficking and calls for a taskforce to tackle the trafficking and exploitation of children in Ireland.

90. This Ard Fheis calls for the submission of a bill to call on the government to provide equal funding, including tax reliefs to be made available to those wishing to make a prolife choice.

91. That the asylum process is streamlined to allow a decision to be made within a maximum of two years, in the interest of social justice, avoiding people being left in uncertainty, in reception centres for many years.

92. That Aontú stands behind the family in all its forms, not forgetting the traditional family.

93. Aontú supports biological women's rights to their own spaces and asserts that it is not a hate crime to state and support same.

94. That this Ard Fheis recognises that the role described in Article 41 of the Constitution as being undertaken by 'woman' and 'mothers' in the home is also undertaken by men and fathers. Accordingly, this Ard Fheis calls for a basic income to be provided by the Government to the parent who undertakes these duties in the home.

95. That this Ard Fheis calls on the government to provide support and care to all children and adults who have been diagnosed with gender dysphoria. This Ard Fheis recognises the challenges and difficulties experienced by people who struggle with their identity. Calls on the government to base medical supports and treatment for people with gender dysphoria on science and best medical evidence. That this Ard Fheis recognises that a woman is an adult, human, female and the scientific fact that sex is binary. Accordingly, this Ard Fheis calls for the reform of the Gender Recognition Act 2015.

96. That this Ard Fheis calls upon the Government to designate Good Friday as a Public Holiday in the State.

97. That this Ard Fheis recognises that most Irish people want to help those who are fleeing from violence, war and famine and that many refugees and migrants have been welcomed successfully in many parts of Ireland.

The Ard Fheis also recognizes the positive contribution that is made by many immigrants to Ireland every day in every walk of life. This Ard Fheis calls on the government to ensure that Ireland's immigration policies are sustainable and manageable, that local communities are consulted with and that there is a community dividend for communities who accept migrants.

That all people flying to Ireland from other EU countries should have their travel documents in order, that the law is fully implemented for all individuals who have been deemed not to be asylum seekers by the state application process and that the asylum application process wait time is reduced to a maximum of 6 months in total.

98. This Ard fheis notes with concern, the issue facing women who choose life for their babies, in the instance of pregnancy following rape. Currently men can and do have access to children they have conceived through rape, regardless of the risk they present to the mother. Affirming Aontu's pro-life ethos, Ard Fheis wishes to move to urge both Governments in the 32 Counties, to mitigate any negative consequences for these women in choosing life in such circumstance by removing the implied parent rights of convicted rapists, while allowing courts to grant access only when it is in the clear interest of the child to do so.

99. This Ard Fheis calls on the Government to ensure that entry would only be allowed to migrants without criminal convictions.

Wicklow Cumann

100. This Ard Fheis calls for an investigation on the impact that holding large amounts of immigrants in hotels has had on other businesses in the tourism sector and seeks the provision of the necessary supports to communities.

Westmeath Cumann

101. That this Ard Fheis upholds the guarantee that all citizens can profess their faith without unwarranted restriction.

Plunkett Cumann, Belfast

100. Ógra Aontú proposes that a solution similar to the V-chip used in the United States be considered to allow parents greater control of what their children watch on television and streaming services.

101. This Ard Fheis calls on the government to investigate the rate of suicide among those residing in Direct Provision Centres in the State and to provide greater mental health supports to asylum seekers.

106. This Ard Fheis condemns the taking of life from conception to natural death and encourages its citizens to be pro-active in asserting the right to life of all. This Ard Fheis condemns the Minister for Health for abdicating his responsibility to provide positive alternative options for women considering abortion while at the same time allocating huge sums of money for the promotion and expansion of abortion services.

107. That this Ard Fheis supports the work of Irish Palliative Care teams and strongly opposes the passing of the 'Dying with Dignity' Bill, which would mark a further step in devaluing life in Irish Society.

Regional, Rural, Agricultural and Environmental Affairs

112. That this Ard Fheis recognises that the food market is very profitable, that factories and supermarkets are reaping massive profits, paying little tax and forcing down farm prices. This Ard Fheis calls on the government to reduce the oligopoly power of factories and supermarkets and ensure that farmers get a fair price for their work.

This Ard Fheis calls for the resignation of Minister Eamon Ryan.

Corrib Cumann, Galway

113. This Ard Fheis demands that the government stop punishing people for not taking up ecological innovations and adapt a culture of encouragement instead and for the removal of taxes on carbon negative and carbon neutral products to encourage their uptake.

Corrib Cumann Galway

114. This Ard Fheis calls for an increase in investment in Road Safety nationwide, and consultation with local communities about their everyday experiences with this.

115. This Ard Fheis calls for the introduction of separate electrical metering for heat pumps and electric car charging at the home, as was done for storage heating decades ago. This can be charged at a lower rate allowing uptake without being unaffordable.

116. This Ard Fheis calls on the government to look at the feasibility of the development of remaining areas of the canal network in the west of Ireland as a tourist asset, with potential to build small housing developments along access and utility points such as locks, etc.

120. This Ard Fheis calls on the government to guarantee the rights of vehicle users in respect of public roads and to commit to not allowing further redesignation of road space without significant and regular public consultation.

121. This Ard Fheis supports the construction of the Galway Ring Road.

122. This Ard Fheis supports the reopening of the western rail corridor, in particular the extension of the existing line from Limerick to Athenry, through to Tuam and Claremorris.

123. That this Ard Fheis calls for the required referendums and action towards the relocation of both houses of the Oireachtas out of Dublin to a more central location, as first step towards devolving power from central government to regional and local government.

124. This Ard Fheis commits to taking a more proactive approach to environmental issues and should work towards a policy that takes a pragmatic approach to matters such as clean energy or plastics.

125. This Ard Fheis commits to the protection of the Moore Street Battlefield Site and all National Monuments in Ireland and calls for proper investment in heritage and cultural projects.

126. This Ard Fheis calls on the Government to undertake research to determine what tax breaks for persons who hold a green cert qualification could be developed to entice young farmers to remain in the agricultural sector.

127. This Ard Fheis calls for a government grant to all schools to install Solar PV panels, to be repaid over five years with savings from electricity generated.

128. This Ard Fheis calls for a radical and far-reaching review of the campaign against Bovine TB in this country. We believe many people profit from the lucrative business of TB control and, as a result, little is done to seriously tackle this problem. We want this issue to be addressed to soften the blow on farmers, and practice integrity with curbing this disease.

129. That this Ard Fheis supports a diesel rebate from Revenue for HVO which is a renewable diesel made from lipids like vegetable oil or used cooking oil, and which can be availed of by Haulage companies. This low carbon biofuel serves as a direct replacement for regular fuel. The Government should incentivise more companies to use this biofuel by allowing companies add HVO bills to their rebate list.

134. 135. This Ard Fheis recognises that although wind power is a valuable and sustainable source of renewable energy, it is essential to respect the concerns and interests of local communities affected by wind farm projects. This Ard Fheis therefore emphasizes the necessity of transparent and meaningful consultation with local communities on the planning and construction of wind farms.

136. This Ard Fheis condemns the southern and northern administrations for their failure to decentralize services and provision of infrastructure to the regions and calls on the government to prioritize regional infrastructural investment.

Navan Cumann

137. That this Ard Fheis encourages farming and fishing as natural, healthy and profitable enterprises, good for our environment and the security of our state. We enjoy natural abundance on land and on sea. These natural resources are internationally famous, and the squandering of these resources and the skills to exploit them, must not be surrendered. Aontú supports our relationship with the EU and considers the free movement of people and goods to be good for Ireland. The overly compliant actions of our European representatives with respect to European regulations/legislation, is in our view treasonous to the welfare of our Nation, our natural advantages, and our people. In the event that the Local Authority is unable to obtain a broad consensus in relation to such matters, including consensus on Local Area Plans, it may undertake a Plebiscite, which shall be binding on both parties.

Housing

141. That this Ard Fheis calls for the average turnaround time for the re-rental of Local Authority homes to be reduced to 1 month. This Ard Fheis calls on the Minister for Public Expenditure to ensure that monies collected from the Vacant Homes Tax are used to fund a grant scheme for the refurbishment of vacant houses. This Ard Fheis calls for a relaxation on qualification criteria for the Vacant Property Refurbishment Grant.

142. The government needs to separate the Homelessness Crisis from the Housing Crisis. The Housing crisis will take years of investing by both private builders and local authorities to solve. The immediate Homelessness Crisis is one that can be solved in about two years by the provision of temporary modular housing units appropriately distributed throughout the country.

143. This Ard Fheis supports a relaxing of regulations on the construction or erection of modular homes. **Ógra**

144. This Ard Fheis condemns the fact that local authorities around the country have consistently underspent and returned funding to central government, which was earmarked for Traveller Accommodation, in the teeth of a housing crisis. 146. That the Dáil and government take immediate action on the provision of emergency accommodation.

147. This Ard Fheis calls for a prohibition on 'no fault' evictions in cases where the tenant is pregnant, has a disability or a terminal illness. This Ard Fheis calls for pregnant women to be prioritised, in terms of housing allocation, on social housing waiting lists by local authorities across the country.
